# **World Sprints 2004**

## **New Zealand Area Coordinator to the Hilo World Sprints**

NKOA Council has appointed Maggie Greening as the NZ Area Coordinator for the Hilo World Sprints. She will be partially sponsored by NKOA, which is similar to what has happened in previous years.

I know that the highly organised team managers and the contingent will assist Maggie in this role. Kia kaha tatou!!

#### Maggie's main role will be to:

- ensure that a high level of communication is instigated particularly through team managers this will include:
  - the notification to team managers in a timely manner of <u>ANY/ ALL</u> protests that involve New Zealand contingent paddlers;
  - daily briefings and notification of changes to the racing schedule or daily timetable;
- ensure that a high level of discipline within the contingent is maintained through the respective team managers;
- assist with any drug testing procedures if any NZ contingent paddlers are requested to undertake drug tests;
- clarify any racing rules/ processes/ procedures as required;
- ensure that any protests are processed in a timely manner to ensure that no contingent paddler is disadvantaged.

The Event Manager will be appointed in August and advised shortly after.

In our national sprint events evaluation and feedback there was an overwhelming call to include the W1 with the W6 and W12. Council respects the input and advises that there will have to be some changes in the current programme to accommodate this. No doubt Alex will be able to address this issue as he did with the current programme. Kia kaha Alex.

There is a need to tighten up our administration by implementing policies and procedures of good practice to ensure there is consistency throughout our administrative area.
