REGISTRATIONS

TRAVEL

Can managers please advise arrival dates in Hilo. I'll need this to organise practice time allocations.

PRACTICE TIMES

Monday and Tuesday of the week of the event have been allocated a practice times for all countries. A practice schedule hasn't been released yet. Once this is received we will allocate training times to crews. Therefore your arrival date is necessary to facilitate this.

DOPING (DRUG TESTING) AND MEDICAL DECLARATION FORMS

Attached are the Doping and Medical Declaration forms. Please print these off for each paddler to complete and sign, including reserves.

Please send these to me by 30 July. I'll be away from Wellington after this date, so you will need to ensure that they are posted in time.

WAIVER FORMS

Liability Waiver Forms have not been finalised by the Hilo organisation. Once they become available each paddler will be required to complete the form.

LIABILITY INSURANCE

Hilo organisers have advised that there is a possibility of a fee to cover liability insurance. This could be approximately \$16USD per paddler. The organisers are working on this to have an answer to us shortly. I'm going to negotiate for the fee to be paid when I arrive in Hilo.

If you have travel insurance, check with your agent to determine if you have liability cover while participating in the event.

TRANSPORTATION

Hilo organisers have advised that they can assist with the following transfers from the airport in Hilo:

Banyan Drive Hotels or the Halani Village National Guard Armory, from August 7, Saturday through August 10, Tuesday. If you need transportation from the airport, you must advise us of your flight information, including flight number, times, names of passengers and destination.

An Information Desk will be located at the Hawai'i Naniloa and Hilo Hawaiian so that you can advise us of your departure. We can provide assistance for departures on Sunday, August 15 and Monday, August 16. If you arrive prior to August 7, Saturday, or depart after August 16, Monday, you will need to arrange your own transportation.
