

# **NKOA HPD Programme/ World Sprints 2008**

# **PANUI 3 February 2008**

This is an update on the process towards trialing, coaching and selection for the 2008 World Sprints.

# **Previous Panuis**

## Worlds 2008 Sacramento- Registration/ W1 Trials

Many paddlers have already completed registration and W1 trials. All these paddlers need to do is now ensure they are registered with a Regional Programme by April 1 2008.

The opportunity for other paddlers to register for the Worlds has been extended to **February 25 2008**. This is the last date for registration and the following two requirements must be met by that date – no exceptions.

(1) The paddler must have completed a W1 trial (see previous panuis for detail on how these trials are run). You need to complete an authorised trial through one of the regional coordinators. Please note that, as trials have already been held, no region is under any obligation to hold a further trial. So you cannot demand, only ask. For information contact:-

(2) The paddler must pay a \$150 fee to cover the Regional Coaching Programme that will be conducted as training towards the Worlds. The fee should be paid to the Region running the W1 trial. However the fee may later be transferred if the paddler joins another Region's Programme. The fee is non-refundable.
