Louise expressed 18 years devotion and service to Waka Ama from humble beginnings whereby all clubs throughout the country had representation at AGMs. The first IPCF/IVF worlds for Aotearoa was held at Orakei Basin, Auckland, Jan 1990, and Tatou Hoe/NKOA first Nationals held at Lake Karapiro, Mar/Apr 1990. The first NZ contingency to Worlds event was Sacramento 1992.

Louise also has hopes and wishes for Waka Ama to maintain own identity and hold on to the kaupapa that makes waka ama in Aotearoa unique, and to understand and appreciate dynamics and needs of different regions. The history of Tatou Hoe/NKOA to be collated and written for future reference by Maggie and Louise.

The geographic boundaries of influence of these bodies shall be set at the AGM of NKOA held in any uneven year (eg. 2003, 2005) upon recommendations prepared by the Council after full consultation with existing members and distributed to all Region as at least 60 days prior to that AGM by the Secretary of the Council.'
